



PALL-X 96 WOOD FLOOR WORLD CUP

CONDITIONS OF PARTICIPATION

The competition is organized by PALLMANN GmbH.

Every wood flooring company and contractor who uses PALLMANN products in their business is entitled to participate („Participant“).

The eligibility to participate is limited to the following countries: Germany, Austria, France, Sweden, Spain, Portugal, Argentina, Uruguay, United Kingdom, USA, Poland, Switzerland, Czech Republic, Finland, Holland, Azerbaijan, Georgia, Belarus, Russia, Ukraine, New Zealand, Australia.

In the competition, participants are asked to send pictures of their best PALL-X 96 project, these should give an overall impression of their craftsmanship and finished surface (entries“). The pictures can be sent via using the online form www.woodfloorworldcup.com or by e-mail to wfwc@pallmann.net, enclosing these conditions of entry. It is not permitted to send in several entries.

By participating, the participant grants PALLMANN GmbH the irrevocable right of use, storage and utilization of all photos submitted within the scope of this competition, without any restrictions in time and place. PALLMANN GmbH receives the rights without limitation, also for repeated utilization by all known types of use, publication, publication purposes, on the Internet as well as for presentation at events. By participating, the participant confirms that he/she is entitled to grant the aforementioned rights of use and indemnifies PALLMANN GmbH against any claims of third parties. PALLMANN GmbH may transfer or sub-license the

rights of use thus granted exclusively to affiliated companies in accordance with § 15 AktG, any transfer or sub-licensing to other third parties is excluded. As of December 9, 2020, a national winner in each participating country will be selected from all entries at the discretion of PALLMANN GmbH, personally notified and announced on www.woodfloorworldcup.com and all other PALLMANN websites. The thus selected national winners will participate in the final round on June 9, 2021. The travel expenses of the national winners (in case of participating companies only one person) will be paid by PALLMANN GmbH. The booking of the trip is made by PALLMANN GmbH. If the selected national winner is not able to participate in the final round, PALLMANN GmbH reserves the right to appoint another national winner.

For the realization of the competition, PALLMANN GmbH processes certain personal data of the participants, such as first name, last name, photograph (picture of the participant), address, telephone number or e-mail address. 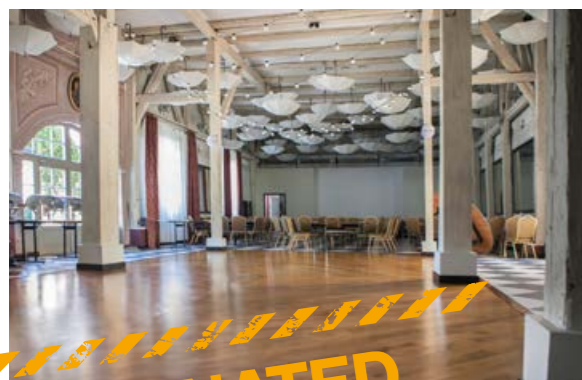

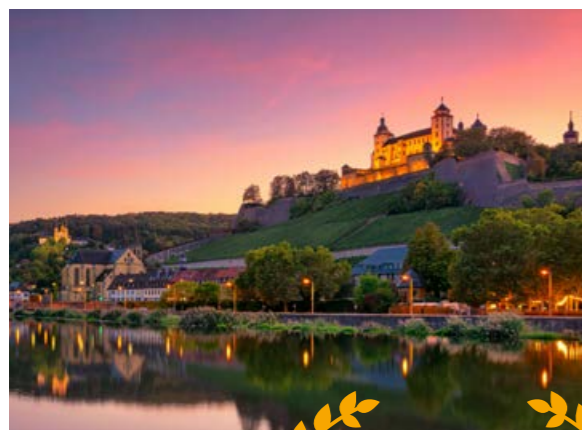
